

There are two application processes – one for Camosun College and one for the Victoria Conservatory of Music.

Both must be complete by the deadline for which you are applying (see below).

Applications submitted after June 1 - July 31 are accepted only when space exists, upon recommendation from Conservatory postsecondary faculty.

## For Camosun

### APPLICATION FORM (INTERNATIONAL)

Submit the International Student Application Form at [camosun.ca/international/future-students](http://camosun.ca/international/future-students) then more instructions and information will be provided by your admissions officer.

There are two basic admission requirements for Camosun:

1. You must be 19 years old by your first day of studies at Camosun.
2. Or, completed high school.

For direct entry into academic programs, Camosun requires Canadian Grade 12 English with a minimum C+. Academic IELTS and TOEFL taken within the last two years are accepted.

English requirement for direct entry:

- Academic IELTS score of 6.0 with no individual band less than 6.0
- TOEFL iBT score of 78 with no score less than 19 on each level

If you do not have these requirements, you must write an assessment test upon your arrival at the College. Requirements are subject to change without notice.

Certificate in Music Creativity and Performance: **\$100 Canadian**

Certificate in Music Technologies: **\$90 Canadian**

### AUDITION AND THEORY PLACEMENT ASSESSMENT (TPA):

The TPA assesses your level of music theory knowledge. Students who have completed MUSF 121, MUSC 111, or RCM Grade 8 theory with a C grade or higher are exempt from this requirement.
